BY-LAW NO. 17-083

**To Amend By-law No. 05-200,
Respecting a Pilot Project for Entertainment on Outdoor Commercial Patios
generally located in the areas of Downtown Hamilton, and for certain lands Zoned
Open Space (P4) Zone and Settlement Commercial (S2) Zone in the Rural Area**

WHEREAS, the City of Hamilton's new comprehensive Zoning By-law, being By-law 05-200, came into force on May 25, 2005;

WHEREAS, the Council of the City of Hamilton, in adopting Item 5 of Report 17-007 of the Planning Committee, at its meeting held on April 26, 2017, which recommended that Zoning By-law No. 05-200 be amended as hereinafter provided; and

WHEREAS, this By-law conforms with the Rural and Urban Hamilton Official Plans.

NOW THEREFORE the Council of the City of Hamilton enacts as follows:

1.
