Detailed Narrative:

This visit was conducted in response to workplace incident involving an injured worker, reported to the Ministry of Labour, Immigration, Training and Skills Development by the employer, that occurred on 7 June 2023.

Inspector Comments

- The details of the incident were discussed with the workplace parties.
- The equipment and PPE involved was observed.
- The injured workers training records were reviewed.
- Training had not been provided to the workers regarding the use of handheld power tools. (ORDER ISSUED)
- The standard operating procedure (SOP) for the line painter was reviewed, and found to not include the procedure for mixing paint.
- The employer stated that a SOP for the use of handheld power tools, following the manufacturers manual/recommendations would be developed by the end of this week.
